Ordinance # 5/9/87

PROPOSED ORDINANCE in reference to an ordinance to control the placement of unlicensed automobiles, trucks and recreational vehicles.

- A. No person, firm, partnership or corporation within the Town of New Haven, County of Adams, shall store unlicensed automobiles, trucks or recreational vehicles a distance from the centerline of any town road, county trunk or state highway less than indicated by the following:

Town Road ..... 83 ft.  
County Trunk .... 108 ft.  
State Highway ... 125 ft.

**B. EXCEPTIONS TO PART A**

1. Persons may store without a permit unlicensed operable or inoperable vehicles, parts cars and parts thereof on his or her property provided the vehicles and parts cars and the outdoor storage area are maintained in such a manner that they do not constitute a hazard and are screened from ordinary public view by means of a fence, rapidly growing trees, shrubbery or other appropriate means.
2. Persons engaged in the business of repairing, working on, or being otherwise involved with for the purpose of profit and holding a valid Wisconsin State Sales Tax Permit, may keep the afore mentioned vehicles less than the distances from the road indicated in Part A of this ordinance when a permit to do so is issued by the Town Board.
3. Persons wishing to keep vehicles such as a semi-truck trailer or bus for the purpose of storage may do so without a permit provided the unit is placed in such a manner as not to constitute a traffic hazard and that all stored materials are kept inside the storage unit.
4. Vehicles up to and including a number of two (2) may be kept on real property providing the following provisions are observed:
  - a. Vehicles are in whole condition where EXTERNAL parts are concerned.
  - b. Vehicles are kept in an upright position and distances under Paragraph A are maintained.
  - c. Window glass is intact or covered in such a manner as not to be recognized as broken

C. PERMIT ISSUANCE AND FEE

1. A permit for the purpose described in Part B, Section 2 when applied for by mail will be granted by the Town Board within five (5) days following the regular Board Meeting.
2. Fee for the above permit will be \$15.00

D. VIOLATIONS AND PENALTY

1. Persons not complying with the rules of this ordinance must return to the Town Board with an alternate plan within thirty (30) days of having been notified by the Town Board of non-compliance of this ordinance or be subject to the provisions of penalty under Part D, Section 2.
  2. Any person, firm, partnership or corporation violating any of the provisions herein after thirty (30) days following receipt of written warning authorized by the Town Board shall upon conviction be fined \$10.00. Each day of violation, after the thirty (30) day warning provision shall constitute a separate and distinct offense. The annual cumulative fine shall not exceed \$300.00.
- E. This ordinance shall be in full force and in effect June 1, 1988.
